**Notes of Decisions**

When a jury has been selected and is waiting in an eminent domain case, and the Commonwealth attorney, present and functioning as an officer of the Court, then and there enters into a settlement agreement after checking with departmental headquarters, the settlement agreement is enforceable even if the attorney failed to check far enough up in the official hierarchy, as directed by § 141.33. *Department of Transportation v. Limestone Products & Supply Co.*, 456 A.2d 706, 707 (Pa. Commw. 1983).
